- Founded by Maribeth Vander Weele in 2003 after she authored a then-renowned plan to turn around Chicago Public Schools. She served on the management team and subsequently as Inspector General.
- Provided broad oversight and fraud investigation services to corporate and public sector clients.
- In 2018, committed to a sole focus on oversight of Federally funded grant programs.

Sample Projects

- Created a comprehensive monitoring program for more than 30
 Federal and state education grants at the North Dakota Department of Public Instruction.
- Since 2018, the Illinois State Board of Education engaged our firm to create and execute a risk-based monitoring program to oversee \$6.9 billion in Federal grants for Chicago Public Schools, and since 2020, for nine other districts.
- Monitored \$600 million for services provided to students with disabilities in New Jersey.
- Monitored a \$50 million dollar grant providing high-impact tutoring interventions to students in New Jersey who were disproportionately impacted by the COVID-19 pandemic.
- Monitored effectiveness and spending of Federal grant monies at 183 schools in 23 states for the Bureau of Indian Education.
- Monitor quality and compliance for early childhood home visiting and daycare programs in Illinois and assess home visiting practices for the Early Head Start Program in the City of Phoenix.
- Monitor \$180 million in grant funds to improve air quality and energy performance in schools and businesses in New Jersey.
- Designed a grants monitoring program and mapped grant business processes for the New Jersey Department of Community Affairs to manage \$6.2 billion in American Rescue Plan grants to 28 state agencies for 103 programs.
- Our founder Maribeth Vander Weele wrote the book Reclaiming Our Schools, which became the roadmap for reform of the \$3.8 billion Chicago Public School system and, as a key member of the management team, spearheaded transformative initiatives.
