Sample Projects

- Engaged as an integrity monitor with the New Jersey Board of Public Utilities (NJBPU) to monitor \$180 million in grant funds designated to improve air quality and energy performance in schools and small businesses. We performed:
 - a risk assessment to assess how the NJBPU and program administrators have planned to manage risks in administering the School and Small Business Ventilation and Energy Efficiency Verification and Report (SSB-VEEVR) and the School and Small Business Noncompliant Plumbing Fixture and Appliance (SSB-NPFA) programs,
 - a comparative risk assessment to determine and monitor selected districts to ensure all expenditures were allowable, properly documented, and aligned with applicable. regulations.
- Designed a grants monitoring program and mapped grant business processes for the New Jersey Department of Community Affairs to manage \$6.2 billion in American Rescue Plan Act (ARPA) grants to 28 state agencies for 103 programs.
- Monitoring seven infrastructure projects totaling more than \$700 million in American Rescue Plan Act funds in New Jersey.
- For one of the infrastructure projects in New Jersey, monitoring \$300 million in water infrastructure loans designed to provide access to clean drinking water across New Jersey.
